Sealed BIDS for the Ella Street Extension Rehabilitation Project (herein called the Project), will be received by the City of Anderson, (herein called the Owner) at City Hall, 401 South Main Street, Anderson, South Carolina, 29624, until **11 a.m.** local time on **Friday, April 5th, 2019**, at which time and place all BIDS will be publicly opened and read aloud.

The Project consists of, but is not limited to, the following:

This project consists of the demolition and replacement of existing asphalt surface, replacement of existing water and sanitary sewer lines, construction of an additional storm drain line and swale, project management, erosion control, etc. The site area is approximately 0.5 acres.

A Pre-Bid meeting will be held at **11:00 a.m.** local time, **Tuesday, March 26th, 2019** at the project site located at the intersection of Ella Street Extension and E. Mauldin Street (behind Propp Drugs) . Representatives of the Owner will be present to discuss the project. Bidders are encouraged to attend and participate in the conference. Engineer will transmit to all prospective Bidders of record such Addenda as Engineer considers necessary in response to questions arising at the conference. Oral statements may not be relied upon and will not be binding or legally effective.

A Bid Bond in the amount of five percent (5%) of the bid amount will be required. A Performance Bond and a Payment Bond, each in the amount of one hundred percent (100%) of the contract, must be furnished by the successful bidder within 15 days after award of the contract.

A notice of intent to award will be posted to the City website and emailed to all bidders on or before **Wednesday, April 10th, 2019**. Any actual bidder, contractor, or subcontractor who is aggrieved in connection with the intended award shall protest to the City Manager in writing with in fifteen (15) days of the date of notification.

Each Bidder must be qualified under the provisions of the South Carolina Contractor's Licensing Law, 1976 Code, Section 40-11-10, et seq.

The Owner reserves the right to reject any or all bids as provided in Section 16, Instructions to Bidders, and to waive any informalities and technicalities in the bid. Any bid may be withdrawn prior to the above schedule time for the opening of bids or authorized postponement thereof. Any bid received after the time and date specified will not be considered. No Bidder may withdraw a bid within ninety (90) days after the actual date of bid opening.
