PLAN REVIEW FEES

*Commercial - ½ the cost of the Building Permit Residential - \$25.00

FAST TRACKING FEES

½ the cost of the Building Permit + \$150.00 for a building **under 5,000 sq ft** ½ the cost of the Building Permit + \$300.00 for a building **over 5,000 sq ft**

*SITE PLAN ENGINEERING REVIEW FEES

\$250.00 (less than one half acre)

\$550.00 (greater than one half acre)

plus \$100 per acre or portion thereof for each acre above one for commercial sites *Applies to all Apartment Complexes, Subdivisions, & Commercial Projects
